Hi Chris,

I think I follow what the proposal is now.

It is proposed to replace 6 panel mounted antennae (3 on turrets and 3 on flat walling) and to install just 3 in the locations currently used for the turret antennae. The drawings suggest antennae of similar size and method of fixing. The reduction in numbers will clearly be beneficial.

The other additions are small dishes and equipment to be fixed to the inside of the parapet which will be hardly visible. I have no objection to the internal works.

No objections subject to agreement on colour of panel antennae and fixing.

- 1 300mm dish will be mounted on an existing pole (no objection)

LPA requirements:

- 1. larger scale elevation drawings of the existing and proposed antenna's perhaps rather than elevation drawings of the whole tower
- 2. to explain the difference between the existing and proposed flat panel antennae other than a description which states that they will increase marginally in size. Update on the two applications relating to the tower:

Further details and drawings were requested in addition to the drawings you sent me on 10.2.16. These are set out precisely in the emails below from myself and Gill Bayliss the Conservation Officer. These include more detail of the antenna's (larger scale elevation drawings of the existing and proposed antenna's perhaps rather than elevation drawings of the whole tower?) and also amendments.

I still do not appear to have received those.

As you aware, an application was also submitted by another telecoms provider for more minor telecoms works (a replacement antenna and a small dish on a pole apparently) and this has now been approved (by a different case officer).

The determination of the visual impact of the scheme you submitted would have to be in conjunction with what was recently approved for the other provider.

The current extended deadline is Tue 31st May. As I have not yet received the requested drawings, amendments and information and due to the need to re-consult on the requested details/information, I propose a further time extension to take the decision deadline to Friday 15th July 2016.

An earlier decision is of course possible if you can submit the requested information as soon as possible.

With regard to the other application, relating to the tree mast (ref: SMD/2015/0718), I have received the required consultation responses and no objections were received. I therefore intend to issue the planning decision by 31st May.

It has been brought to my attention there is another telecoms proposal for the tower by EE. There is a current application for works including the installation of three EE antennas. This has been allocated to another Planning Officer and is in progress although no decision has yet been made.

Hi Chris,

I note that Jane Curley has an application for telecommunications equipment also (another provider). We need to ensure that the potential impacts of the two are considered together.

The Flag Tower is a Grade II Listed Building which also stands within the Alton and Farley Conservation Area and the Grade 1 Registered Park and Garden. It is therefore a site of great sensitivity. The LPA has a duty under the 1990 to protect the special historic/architectural interest of the Listed Flag Tower. The NPPF states that great weight should be given to an asset's conservation and any harm requires clear and convincing justification.

The Flag Tower is a robust building which forms part of a designed landscape and has had a history of accommodating telecommunications equipment with several providers. The approach is always to always to look to reduce the telecommunications equipment externally on the building and any increase needs to be fully justified.

This application proposes an intensification of equipment:

- 3 flat panel antennae on the turrets will be replaced with 9
- 2 mid wall antennae will be removed
- 1 non-visible antennae will be removed (no objection)
- 1 300mm dish will be mounted on an existing pole (no objection)

There is no information to explain the difference between the existing and proposed flat panel antennae other than a description which states that they will increase marginally in size. No information is provided on the method of fixing, how far away from the walling they will need to be mounted or how the antennas will relate to the architectural detailing of the turret – further information is required.

There is no doubt that this is a substantial increase in the number of antennas on the turrets which will be seen against the silhouette of the building when viewed from the ground. The repositioning of some antennas from the flat walling to the turrets is regarded as a regrettable step as these were less visible. The proposal therefore causes a degree of harm the special architectural and historic interest of the Listed Building and character and appearance of the Conservation Area.

More detailed information is lacking about the flat panel antennae (highlighted above) and why the additional equipment is needed, why the antennae on the flat wall have to be repositioned and whether there are options elsewhere to provide this service. Given the sensitivity of the site a much more detailed application is required.

As it stands this proposal is lacking in detail and justification. Ideally a revised proposal will need to be reported back to Liaison Panel.
