The overall effect on traffic is unchanged to the previous application 0682. This problem was the main reason for the previous planning applications committee's objection.

The hazards caused by 250,000 visitors on these narrow steep single track roads, are the same as in the previous rejected application 0682.

The attempt to mitigate the situation by installing an advisory ¿No Right Turn¿ sign is pathetic as incoming traffic particularly locals from cheadle, uttoxeter and ashbourne using the swimming pool etc will use their local knowledge and come up through Oakamoor and Carr Bank.Sat Navs will still directtraffic down or up carr bank to achieve the shortest route, endangering residents and other road users.

The sign is only advisory, road users have a legal right to turn right and they may see other locals travelling downhill to Oakamoor and follow suit.

The dangers to holiday makers in the area, those attempting to have a walking holiday and take advantage of the special nature of this beautiful and tranquil valley, will force, and is in fact already forcing visitors to avoid walking along country lanes

Locals will be unable to use their residential roads or walk along lanes safely.

The villages of Oakamoor and Whiston, and the hamlet of Moneystone will be inundated with the kind of traffic that Alton experiences with Alton Towers.

The narrowness of the lanes in the Lower Churnet Valley, Farley Road, Whiston Eaves etc will create dangerous blockages as there are many single track sections and few passing places.

There are already aggressive exchanges with Alton Towers visitors not happy with the blockages which require someone to back up or down blind bends.

Residents have experienced that visitors who are unfamiliar with how to use passing places tend to push forward, attempting to squeeze past. This causes accidents of varying natures. 52 such accidents on Farley Road alone were documented and sent in to both SMDC and SCC at the hearing of the previous application.
