Rachael,

The extended phase I survey is an acceptable standard and identifies the main site constraint as Japanese knotweed.

The chemical control methods detailed in the method statement generally follow advice provided by the Environment Agency at https://www.gov.uk/guidance/prevent-japanese-knotweed-from-spreading#dispose-off-site-safel.

The qualifications of those carrying out chemical control should be detailed. The concentrations of glyphosate to be applied should also be provided. Further details of what the Japanese knotweed membrane consists of should be specified.

The second part of the method statement section 5 page 31 should indicate the details relating to complete site disposal

The actual transfer to a waste disposal site appears to be missing. Advice detailed on the Environment Agency web site should be followed to revise the method statement at:

https://www.gov.uk/guidance/prevent-japanese-knotweed-from-spreading#dispose-off-site-safel

In particular:

Japanese knotweed waste must be dispose of off-site by transferring it to a disposal facility that's permitted, eg a landfill site that has the right environmental permit. The permit must allow the disposal of invasive plants at the landfill site but it won't necessarily specify invasive weeds. Usually the permit will allow biodegradable wastes to be taken and will usually be for non-hazardous wastes.

Before you transfer Japanese knotweed waste you must:

•check with the waste site in advance to make sure it's got a permit to accept material containing invasive plants - the waste site may also need time to prepare

•tell the waste site that you're transferring Japanese knotweed waste

When you transfer the Japanese knotweed waste you must cover or enclose it in the vehicle so that no waste can escape.

After you transfer Japanese knotweed waste

After you've transferred the Japanese knotweed waste at the disposal site you must:

•brush vehicles down vigorously or jet-wash them to clear them of any Japanese knotweed •inspect your vehicles to check there's no trapped pieces of the plant or rhizome

These elements need to be incorporated into the method statement.
