The site is within the Leek development boundary, the applicable H2 policy regarding affordable housing contribution states 'In the towns, residential developments of 15 dwellings (0.5 hectares) or more shall provide a target of 33% affordable housing on-site from all sources'. Initial comments for full planning application for 12 dwellings SMD/2016/0510.

The application is full and as such the detail of any affordable housing contribution will need to be confirmed.

The site is within the Leek development boundary, the applicable H2 policy regarding affordable housing contribution states 'In the towns, residential developments of 15 dwellings (0.5 hectares) or more shall provide a target of 33% affordable housing on-site from all sources'. In the first instance please could clarification be sought form the applicant of the reasons why the number of dwellings has reduced from 16 to 14 dwellings following pre-app consultation? Is there a technical reason why the site could not accommodate more than the 14 dwellings now proposed bearing in mind that 15 or more dwellings would trigger an affordable housing contribution?

Of a 33% affordable housing contribution the Council requires 70% rent and 30% shared ownership/intermediate tenure split across affordable housing. The information submitted by the applicant makes no reference to affordable housing contribution therefore please could clarification from the applicant be provided.

The application proposes 12 open market dwellings; 6x3 bedroom & 6x4+ bedroom dwellings with no mention to affordable housing contribution. In terms of affordable mix, predominantly 2 bed 4 person houses with 3 bed 5 person houses would be considered appropriate. However further detail in this respect will be required pending clarification of the reasons why the number of dwellings has reduced from 16 to 14 dwellings following pre-app consultation?

It is the councils expectation that affordable dwellings will be built to the HCA former Design and Quality Standards and Housing Quality Indicators and will meet the specified size criteria. This criteria ensures that 1b2p dwellings are 45-50m<sup>2</sup> and 2b4p dwellings are 67-75m<sup>2</sup> and 3b5p 2 storey dwellings are 82-85m<sup>2</sup>
