Thanks for the updated arboricultural impact assessment (AIA) report, which now relates to revised proposal as detailed in the current application.

This confirms that the proposed development would have no adverse impact on existing trees.

Whilst the updated AIA report again gives appropriate details (location and specification) for temporary tree protection barriers during construction, I still consider that the elements of the scheme (new build extension and extended drive/parking area) are sufficiently far beyond the Root Protection Areas (c.8m and c.6m respectively) so as to make such tree protection measures not strictly necessary.

My comments on this application therefore remain as set out in my previous e-mail of 26/05/2017 (copy attached for reference), i.e. no objection, and requested condition to secure new tree planting as detailed.
