The drainage plan shows both foul sewage and surface water to discharge to the public combined sewer – please note there are no combined assets within the area, only a public foul sewer. For your information, before we would consider a connection to the public foul sewer for surface water discharge we would request that soakaways are investigated. If these are proven to not be feasible on site (with satisfactory evidence) we would reluctantly consider a connection to the public foul sewer with flows restricted to a minimum flow rate. We therefore would ask that the drainage related condition is not discharged at this stage.
