Good morning James,

Thank you again for your email below.

In regards to your question in relation to the new drainage for the property. Again I have sat down with my managing director Ian Bunn this morning and discussed in detail the new drainage layout.

From a building control perspective and the drawings provided, the new drainage layout appears to look acceptable.

However in order for us to determine whether the drainage system would work, we would require the invert levels for the two existing manholes and the invert levels for any new drains and manholes that are to be added to the existing drainage system. This would be required in order to determine the fall of the drains between the manholes.
