Design & Access Statement for ATM Installation ATM Cardtronics Cashzone

Introduction

This Design and Access Statement has been prepared on behalf of Cardtronics Cashzone in support of an application submitted for the installation of an Automated Teller Machine and illuminated signage.

The initial purpose of the proposal is to provide 24 hour banking facilities for customers using Mace High Street Cheadle.

As this installation is for an ATM within the existing external façade, some aspects such as "layout" and "Access" are of limited applicability.

Design Principles

Design

The site is a Convenience Store in High Street Cheadle. The installed ATM provides direct and unobstructed access and has been installed through the shop front window to the left of the glazed entrance door. Glazing has been replaced with a white laminate security panel incorporating the ATM and top sign. Wincor Procash 2050 ATM fascia with Cashzone illuminated polycarbonate black and green top sign and illuminated green acrylic ATM fascia sign. The Wincor Procash 2050 ATM was installed on 27th March 2018.

Design Principal

The ATM is of a standard design as located in many Convenience Stores throughout the UK and is accepted as a necessary facility. There are a number of mandatory standards which apply relating to the position of the ATM, it's visibility, ambient lighting, building structure, security features, ATM anchoring and ATM safe security and strength.

Scale

The dimensions of the installation are:-

ATM top sign has been set at a height of 1765mm from the pavement level to the underside of the surround signage.

Signage Height 330mm. Width 635mm. in black and green polycarbonate with white internally illuminated lettering and halo illumination.

ATM fascia green acrylic sign has been set at a height of 1590 mm from the pavement level to the underside of the sign.

Signage Height 171mm. Width 466mm in green acrylic with white internally illuminated Cashzone lettering and accepted card logos.

Planning

82-84 High Street Cheadle is not known to be in a Conservation area and is not known to be a Listed Building.

The installed ATM provides direct and unobstructed access and has been installed as a through glass installation.

The display screen is carefully shielded from ambient lighting to prevent glare and reflection, ensuring a clear and sharp image is visual by both standing and seated users.

The ATM has been installed at a suitable height in order that the cash dispenser can be easily accessed, in accordance with DDA regulations

The display screen is carefully shielded from ambient lighting to prevent glare and reflection, ensuring a clear and sharp image is visual by both standing and seated users.

The installation has been designed to anticipate and overcome the restriction that would prevent disabled persons from making full use of the service to be provide together with the needs of more vulnerable people from protection of attack and intimidation.

Community Saftey

This site has a high level of pedestrian and vehicle movement ensuring safe public spaces through natural surveillance.

Cardtronics Cash Zone carry out an end to end solution using Cash in Transit (CIT) and engineering staff, our security managers consider the following for every installation deliveries, parking outside the unit and line of sight of the replenishment for the staff. Cash in Transit (CIT) approval has been obtained for this installation. A CCTV camera is located at high level to the left of the proposed ATM location witch will cover customers using the ATM. Cardtronics Cash Zone believe that their standard working practices and the implementation of the above crime prevention measures help to provide a safe and sustainable development as set out in: ATM Security Working Group ATM Best Practice September 2009

This site has a high level of vehicle and pedestrian movement ensuring safe public spaces through natural surveillance.

Layout

The ATM has been installed at a suitable height in order that the cash dispenser can be easily accessed, in accordance with DDA regulations.

Appearance

The installed ATM is a standard Wincor 2050 Pro Cash design with Cardtronics Cashzone black and green polycarbonate surround signage with illuminated lettering and halo illumination and green acrylic ATM fascia sign.

Access

The installed ATM has good access for the public. Due to the flat surface to the frontage and its position within the frontage.

The ATM is set at a height that makes it accessible for wheel chair users. Key 5 has raised markings for blind persons to identify the centre key.

There is sufficient area in front of the proposed ATM for easy access clear off all pedestrian movement.
